On 05.12.2019. Registrar of respondent University

appeared and vide letter No. BU/Reg/2019/HPPEREC/33835 dated 02.12.2019 submitted that security cheques of all these students named in the said notice have been prepared and some of the students have already collected their cheques. The Registrar of University directed to submit copies of cheques alongwith receiving from students within a month's time. Further the University is directed to refund the security to all passed out students within a week after issuance of PDC whether students applies or not for the refund.
