Lekh Raj.2. 3 employees namely, Kulwinder Kaur, Jagriti and Smriti who were also students at respondent University.3. Qualification of Vice-Chancellor. <p>On point No. 1, Vice-Chancellor of respondent University admitted that Sh. Lekh Raj was appointed as faculty in the department of Civil Engineering at respondent University. FIR has been lodged against Sh. Lekh Raj related to fake degree but could not place the copy of FIR. He further stated that Sh. Lekh Raj has filed a CWP before the Hon'ble High Court of HP against the FIR lodged by the respondent university.</p> <p>On point No. 2, Vice-Chancellor admitted that above mentioned persons are employee of the respondent university and they have been also allowed as student in PG courses as the respondent university has permission to do the same but he failed to place the supporting documents. One name more Sh. Sanjeev Dhiman added with this case on the same issue on the request of petitioner.</p> <p>On point No. 3, Vice-Chancellor admitted that presently he has been appointed Vice-Chancellor of the respondent</p>
