ORDER

WHEREAS, the Joint Secretary University Grants Commission, Ministry of Human Resource Development, Govt. of India had forwarded a complaint received from Sh. T. Nandkumar and others vide his U.O. No. F.14-3/2019(CPP-I/PU) dated 31<sup>st</sup> December, 2019 regarding to selling of large number of degrees by Manav Bharti University, Solan, Himachal Pradesh.

WHEREAS, an FIR No. 27/2020 dated 08.03.2020 U/S 420, 467, 468, 120 B IPC registered at Police Station Dharampur, Distt. Solan, H.P. against the management of Manav Bharti University at Village Laddo, Sultanpur, Distt. Solan.

WHEREAS, the Secretary, H.P. Private Educational Institutions Regulatory Commission vide his letter No. HPPEREC/28/MBU Vol-V/2018-9757 dated 17.07.2020 recommended to appoint an administrator to conduct all the processes to assist the students in providing migration certificates as well as other relevant documents presently lying with Manav Bharti University Solan, for migrating to other Private Universities as per their willingness as well as for conducting exams of final year students of all courses at Manav Bharti University.

WHEREAS, keeping in view the future of the students, who are enrolled in Manav Bharti University, Solan, Shri Anurag Chander, IAS (HP: 2016), Additional Deputy Commissioner (Dev.)-cum-Project Director, DRDA, Solan Distt. Solan, Himachal Pradesh has been appointed as an Administrator of Manav Bharti University, Solan with the prior approval of the competent authority to monitor the functioning of the Manav Bharti University, Village Laddo, Sultanpur, Distt. Solan, HP.

WHEREAS, the Deputy Commissioner, Solan, Distt. Solan has requested to appoint another officers as an Administrator of Manav Bharti University in place of Shri Anurag Chander, IAS (HP: 2016), Additional Deputy Commissioner (Dev.)-cum-Project Director, DRDA, Solan Distt. Solan due to heavy workload.



AND WHEREAS, the request of the Deputy Commissioner, Solan has been considered and it has been decided to appoint another suitable Officer as an Administrator of Manav Bharti University in place of Shri Anurag Chander, IAS (HP: 2016).

NOW THEREFORE, the Governor, Himachal Pradesh, hereby appoint Shri Rajeev Kumar (HPAS), General Manager, Distt. Industries Centre, Solan Distt. Solan, Himachal Pradesh as an Administrator of Manav Bharti University in place of Sh. Shri Anurag Chander, IAS (HP:2016), Additional Deputy Commissioner (Dev.)-cum-Project Director, DRDA, Solan, Himachal Pradesh to monitor the functioning of the Manav Bharti University, Village Laddo, Sultanpur, Distt. Solan, HP. The Administrator shall look after the University and report the outcome on monthly basis to the HP Private Educational Institutions Regulatory Commission for further directions on following aspects:-

- (i) To ensure effective administration at Manav Bharti University, Solan.
- (ii) To conduct exams of all courses at Manav Bharti University, Solan.
- (iii) To engage teaching faculty and staff as per norms to run the various courses in the University as per requirement.
- (iv) To evaluate the financial resources available at the end of the University and their sufficiency to run the University effectively and to ensure consolidation of income from various sources to pay the pending salaries and regularization thereof.
- (v) To maintain and utilize infrastructural facilities available at the University campus to support the students at studies and stay in the hostels effectively.
- (vi) To report through continued evaluation of the resources to run the University on long term basis and to report remedial measures to be taken to run the University effectively.
- (vii) To assist the students in providing migration certificates as well as other relevant documents presently lying with Manav Bharti University Solan, for migration to other Private Universities as per their


willingness, with prior approval of the concerned university, where the students want to migrate.
