COMPETITION FOR LOGO DESIGN

GUIDELINES FOR PREPARING ENTRIES, OTHER CONDITIONS AND SELECTION PROCESS:

The H.P. Private Educational Institutions Regulatory Commission has been established by the Govt. of Himachal Pradesh under Section 3 of the Himachal Pradesh Private Educational Institutions (Regulatory Commission) Act, 2010 for the purpose of providing a regulatory mechanism in the State and for working as an interface between the State Government and Central Regulatory Bodies for ensuring appropriate standards of admission, teaching examination, research and protection of interest of students in the Private Educational Institutions and for matters connected therewith or incidental thereto;

MANDATE:

- To regulate standards of admission, teaching, examination, research, extension programme, faculty and infrastructure in accordance with the established norms.
- Admission based on merit.
- Grievance Redressal.
- Inspections.
- Power to monitor and regulate fees.

SUBMISSION OF ENTRIES:

The H.P. Private Educational Institutions Regulatory Commission (HP-PERC) invites entries to design a LOGO through public competition. Therefore, all Resident Indians (both professional artists and non-professionals) are hereby invited to participate in a competition for the LOGO DESIGN of HP-PERC. Interested persons may send their entries, accompanied by a brief explanation of the Design and how it best symbolizes the Logo of H.P. Private Educational Institutions Regulatory Commission and also the bio-data of the applicant with a passport size photograph affixed on the top right hand corner.

The entries should reach Secretary, H.P. Private Educational Institutions Regulatory Commission, Majitha House Complex, Shimla, latest by 3 P.M. on 25.01.2013. Entries received after the stipulated time shall not be considered. The Commission shall not be responsible for delay by postal services, courier agencies etc. The entries can also be deposited personally in the office of the Commission. The entries should be sent in a properly sealed envelope labelled "ENTRY FOR LOGO DESIGN of HP-PERC".

GUIDELINES FOR PREPARING ENTRIES:

1. The symbol should be sent only on an A-4 size paper preferably using two colours so reproduction is easy.
2. A graphical construction of the symbol design in exact proportions in a bigger size, along with final design, Theme synopsis and concept is required to be submitted.
3. The symbol should represent "Regulators of Standards of Higher Education, Quality Education as a Window to Growth, Development, Progress etc., integration of name of the organisation and/or Geographical Location of hill State.
4. The size of the final design should not be smaller than 232 square cm (36 sq. inches). It is to be submitted along with minimum TEN different proportionally smaller sizes up to 4 points font size of the text matter. This would be use in letterheads, advertisements, flag etc.
5. The symbol should be original work of the participant and must not infringe the Intellectual Property Rights of any third party.
6. A participant can send a maximum of two entries.
7. The entry could be an individual or a team assignment.

OTHER CONDITIONS:

1. The entries sent once shall not be returned.
2. The final selected symbol shall become the intellectual property of the H.P. Private Educational Institutions Regulatory Commission and the designer shall not have any right over the same.
3. The responsibility to comply with the guidelines and other conditions fully lies with the participant and the H.P. Private Educational Institutions Regulatory Commission shall not be liable for any dispute raised by a third party.

SELECTION PROCESS:

- a) All the entries received by the stipulated date and time and found in order, shall be evaluated by a Committee comprising five members drawn from Art & Culture, Educational Institutions of repute, Govt. of Himachal Pradesh etc.
- b) Five entries shall be shortlisted for final selection. The shortlisted Designers may be required to make a presentation to the Committee. The date, time and venue of the presentation shall be communicated separately to the shortlisted designers.
- c) The Designer of the finally selected design will get a prize of Rs.25,000/- (Rs. twenty five thousand) only and would be required to submit final design both in hard copy and digital format, besides, to surrender copyright of the design to the H.P. Private Educational Institutions Regulatory Commission.

The Chairperson, H.P. Private Educational Institutions Regulatory Commission reserve the right to reject all entries if not suited to the requirement of the Regulatory Commission or cancel the "Logo Design Competition" without assigning any reasons.
