has approved the fee structure of B.Ed. Course for Privately managed colleges w.e.f. the  
introducing the two years B.Ed. course for time to time. You are further requested to  
clarify the following to all Privately managed colleges as under:-

| 6.      | 2 <sup>nd</sup> year of session 2017-19 | 41,920/-  |

You are, therefore, directed to take further necessary action in the  
matter and settle the issues of various complaints raised by the students of Pvt. Managed  
B.Ed. Colleges accordingly. All private colleges be intimated that the extra fees, if any  
charged by them be refunded at once and simultaneously inform that the case of such  
allegations i.e. overcharging the fees are proved, the recognition of those colleges shall  
be withdrawn/ cancelled.
