ORDERS

A review application was filed by Sh. Rakesh Gupta, Chairman, Bells Institute of Management Technology, Mehli Shimla against the orders passed in case No. 09/2017 in the matter Abhinav Bhardari V/s Bells Institute of Management Technology, Mehli Shimla in which he has submitted that the complainant had taken admission in BHM course affiliated to HPU not to HPTU. The approved fee for BHM is Rs. 60,000/- per annum and the student remained in the Institute for 2 semesters and deposited Rs. 60,000/- towards the course fee and is not claiming any amount on account of excess course fee. Further he prayed that student is claiming only Rs. 5,000/- in account of hostel

fee paid by him for the duration he did not stay in the hostel. The case was heard on 26/02/2019 in which neither the applicant nor the complainant were present. The case was again heard on 14/03/2019 and the applicant Sh. Rakesh Gupta Chairman, Bells Institute of management Tech. Stated that Student had only paid Rs. 60,000/- for which he produced the copies of receipt also. The case was again heard on 04/04/2019 and the complainant submitted that the two receipts dated 10/04/2017 and 26/12/2016 refers to a same amount of Rs. 30,000/- deposited by the complainant Mr. Abhinav Bhandari. The case was again heard on 24/06/2019 and on perusal of the same it was established that Mr. Abhinav Bhandari has paid Rs. 60,000/- only as tuition fee and not Rs. 90,000/- as earlier mentioned which was also agreed by both the parties. The plea was considered, therefore the amount of Rs. 5,000/- only had to be refunded to the complainant. Moreover on the directions of the Commission Mr. Abinav Bhandari the Complainant sent an email mentioning that the issue has been resolved and no further proceedings are needed in this matter.

Since the relief as per orders of the Commission has already been granted, therefore the review petition is disposed of.
