Subject: Final Fee Structure in respect of Indus International University,
District Una, H.P. for the academic session 2015-16.

Sir,

I am directed to refer to the subject cited above and to say that as per the provisions contained in Section 32 of the University Act, the fee structure is required to be approved by the Government on receipt of proposal from the University.

On receipt of fee structure proposals for the academic session 2015-16, the Government on the recommendations of the Fee Structure Committee, has approved the fee structure of your University as per Annexure- 'N.', subject to the following terms and conditions:-

1. The approval of fee structure of new courses for the academic session 2015-16 shall be subject to the condition that the same shall be applicable only after the approval by the Government/ Regulatory Commission to run these courses.
2. The fee structure of all other courses excluding those where the fee structure is revised and which appear in the Annexure- 'N.', will remain the same as of the year 2014-15.
3. The fee structure for M.Phil & Ph.D. courses will be considered/ approved separately by the Government in due course of time after receiving requests in this regard.

4. The University shall engage the faculty as per the norms fixed by the Regulatory Bodies viz. UGC, AICTE, BCI, MCI, etc. and comply with the UGC (Establishment and Maintenance of standards in Private Universities Regulations), 2003.
5. The University shall comply with the UGC "Mandatory Assessment and Accreditation of Higher Educational Institutions" Regulations, 2012.
6. The University shall give the details of regular faculty and details of physical academic infrastructure in the prospectus for the information of students, general public and State Government and the copy of the said prospectus shall be provided to the Government before starting of the academic session. Further, the details of the entire faculty including contract/ part time should be available alongwith their photos, qualification and bio-data in the official website of the University.
7. The infrastructure viz. computers, labs and other equipments shall be provided as per norms of the concerned regulating bodies and shall be available before the start of that course.
8. The Tuition Fee shall be charged annually, in two equal installments and the dates for depositing of fee, be clearly written in the Prospectus.
9. The Institutional Development Charges shall be ₹10,000/- for the University, to be charged annually.
10. One time Caution Money for Hostel shall be ₹5,000/- and for the University it shall be ₹10,000/-, which is refundable.
11. The University shall charge the fees under the four heads only and no other fees shall be charged under any other head by the University.
12. The University shall clearly categorize the fees for hostellers and non-hostellers, as the case may be and the details thereof as approved by the Government shall be given in the prospectus.
13. The hostel charges approved for the academic session 2014-15 in favour of Private Universities shall continue for the academic session 2015-16 except in few cases. In order to maintain uniformity in Hostel Charges in

all the Private Universities the Hostel Charges have been decreased in case of few Private Universities.

14. The University shall encourage and implement all the welfare schemes applicable for the staff as well for the students.
15. The 10% (Ten percent) seats in all courses for the academic session 2015-16 shall be reserved for Himachali Bonafide BPL/ IRDP candidates in all Private Universities on free of "TUITION FEE BASIS".
16. If any course(s) / degree(s) / program(s) is not recognized by the UGC for which the fee has been approved, the same shall be deemed to be NOT APPROVED.
17. The fee structure approved for courses for the year 2014-15, shall not be applicable for this year, if the courses are not approved by the Regulatory Commission / Government for continuation.
18. The fee structure shall be applicable from the academic session 2015-16 for the new batch and for the complete duration of the course. The old batch should be charged as per the earlier approved fee structure till completion of their course.
19. As per the provisions of the Section 8(a) of the H.P. Private Educational Institutions (Regulatory Commission) Act, 2010, upto one percent fee as assessed by the Regulatory Commission is required to be credited to the fund established vide Act ibid. The same should be charged as per such percentage of the total fees as would be assessed by the Regulatory Commission for the academic session 2015-16 under the Section 8(a) of the Act ibid, subject to the final outcome of the CWP no.10140/2012-D and further partial stay granted by the Hon'ble Supreme Court of India on dated 08/05/2014 in Civil Appeal no. 11290/2013 filed by the State Government.
20. In case any deficiency is observed at any later stage or it is found that the fee in excess has been charged, necessary appropriate action as per Law shall be initiated against the University.

You are therefore directed to take further necessary action strictly as per the above stated terms and conditions under intimation to this department, immediately.
